ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF INTER-CARGO IMPORT/EXPORT OF SOUTHWEST FLORIDA, INC.



Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is INTER-CARGO IMPORT/EXPORT OF SOUTHWEST FLORIDA, INC.
- 2. The following Amendments to the Articles of Incorporation was adopted by all of the Directors and the Stockholders of the Corporation eligible to vote by the execution of a written statement manifesting their intention that such amendment be adopted, dated the day of warreh, 1999, in the manner prescribed by Section 607.1003 of the Florida Business Corporation Act:

Article II of the Articles of Incorporation is amended to read as follows:

ARTICLE II Principal Office

The principal place for the transaction of the corporation business shall be 2529 North Airport Road, the City of Fort Myers, County of Lee, in the State of Florida, 33907, and the mailing address shall be the same.
