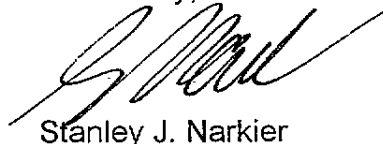

**ARTICLE I - NAME:**

The name of this corporation is ***J. WALK PAINTING AND DECORATING, INC.***

**ARTICLE II - DURATION:**

This corporation shall commence on the date of filing of these articles with the Secretary of State and shall have a perpetual existence.

**ARTICLE III - PURPOSE:**
