WHEREAS, Articles of Incorporation were filed on April 21, 1998 for TV 3 Entertainment Corp. ("Corporation"); and

WHEREAS, due to a clerical error the name of the Corporation was incorrectly stated in the Articles of Incorporation as TV Entertainment 3 Corp. and the initial director was incorrectly named; and

WHEREAS, no shares of stock have been issued and no officers elected; and

WHEREAS, this Articles of Correction is being filed by the incorporator to correct Article I and Article VIII thereof.

Article I and Article VIII are hereby amended to read as follows:

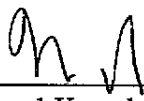
**ARTICLE I - NAME**

The name of this Corporation shall be TV 3 ENTERTAINMENT CORP., a Florida corporation ("Corporation").

**ARTICLE VIII - BOARD OF DIRECTORS**

This Corporation shall have an initial Board of Directors consisting of one (1) Director. The initial director shall be James Perretty, whose address is 2255 Glades Road, Suite 124A, Boca Raton, Florida 33431. The number of Directors may be changed from time to time by the Bylaws of the Corporation, provided that the Board of Directors shall at all times have no less than one (1) director and no more than five (5) directors.
