ARTICLES OF INCORPORATION

OF

THE DAVIDE CORPORATION



I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I NAME and PRINCIPAL OFFICE

The name of this corporation shall be The Davide Corporation and the principal place of business and mailing address of this corporation shall be:
