# ARTICLES OF INCORPORATION FOR BERNARDO'S DESIGNS, INC.

SECRETARY OF STATIONS

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation the purpose of creating a corporation under the laws of the State of Florida.
