OF

ARTICLE I - NAME

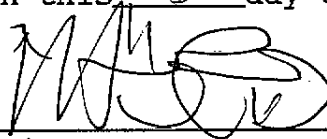
ARTICLE XIV - SHAREHOLDERS QUORUM AND VOTING

IN WITNESS WHEREOF, the undersigned subscribers have executed these Articles of Incorporation this 5 day of April 1998.

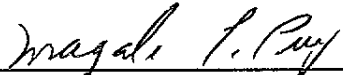

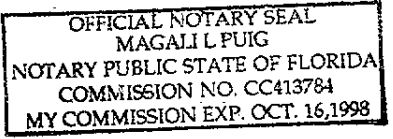
