ARTICLE I

NAME

THE NAME OF THIS CORPORATION SHALL BE: MURRAY COMMUNICATIONS, INC.

ARTICLE II

DURATION

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE III

PURPOSE

THIS CORPORATION IS ORGANIZED FOR THE PURPOSE OF SERVING THE TELCOMMUNICATIONS INDUSTRY AND FOR THE PURPOSE OF TRANSACTING ANY AND ALL OTHER LAWFUL BUSINESS.

ARTICLE IV
