ARTICLES OF INCORPORATION OF MANATEE COUNTY COLLECTIONS, INC.



The undersigned, acting as an incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Manatee County Collections, Inc.

ARTICLE II

This corporation shall exist perpetually and shall commence on April 14, 1998 after the filing of these Articles of Incorporation by the Department of State, State of Florida.

ARTICLE III

The purpose or purposes for which the corporation is organized are to engage in a general account collections business and to do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida corporation laws or by other law, or by these articles of incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

ARTICLE IV

Authorized Shares. The aggregate number of shares that the corporation shall have the authority to issue is 100 shares of Capital Stock with a value of \$1.00 par value.

Stated capital. The sum of the value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.
