ARTICLES OF INCORPORATION

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is JONOR, Inc. and the principal address is 13101 56th Court, Suite 803A, Clearwater, FL 33760.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is 17757 U.S. Highway 19 North, Suite 500, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Mason & Associates, P.A.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.

ARTICLE IV - AUTHORIZED SHARES OF STOCK
