ARTICLE I - NAME

The name of this corporation shall be FTP ENTERPRISES, INC., and the address of the principal office of the corporation is 12450 SE 58th Lane, Morriston, Florida 32668.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of conducting any and all lawful business.

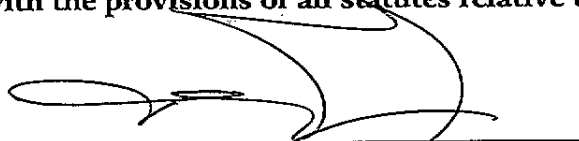
