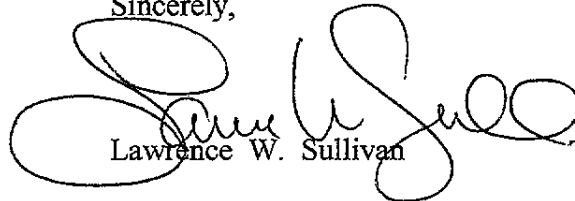

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation is Pentacon General Contracting, Inc.

ARTICLE II. TERM OF EXISTENCE

The corporation shall begin its corporate existence as of the filing of these Articles of Incorporation and shall exist perpetually.

ARTICLE III. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 7500 Beach Boulevard, Jacksonville, Florida 32216.

ARTICLE IV. GENERAL PURPOSES

The general purposes for which the corporation is organized shall be:

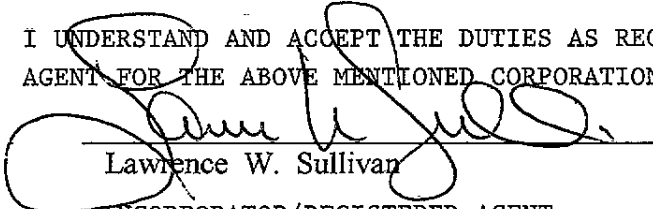
