We hereby associate to form a stock corporation under the provisions of Chapter 607 of the laws of the State of Florida and to that end set forth the following:

ARTICLE I: NAME OF CORPORATION

The name of the Corporation is 527, INC., 5460 Lyons Road, Coconut Creek, FL 33073.

ARTICLE II: PURPOSES OF THE CORPORATION

The purpose for which the Corporation is organized is:

- A. Entertainment Management
- B. To engage in any or all lawful business for which comporation may be incorporated under Florida's statutory corporation law or under any act amendatory thereof supplemental there to or in substitution therefore.

ARTICLE III: POWERS OF THE CORPORATION
