ARTICLES OF INCORPORATION

OF

SCRIMA STABLES & ASSOCIATES, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the Laws of the State of Florida.

ARTICLE I - NAME OF CORPORATION

The name of the corporation is SCRIMA STABLES & ASSOCIATES, INC..

The address of the principal office of this corporation shall be 68 South Ivanhoe Blvd., Orlando, Florida 32804.

ARTICLE II - TERM OF EXISTENCE

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these Articles.

<u> ARTICLE III - NATURE OF BUSINESS</u>
