# ARTICLE ONE - NAME & ADDRESS

The name of the Corporation is **Bees Tees, INC.**, and the principle place of business of this corporation shall be: 12087 62nd Street North #4, Largo, FL 33773.

## ARTICLE TWO - NATURE OF BUSINESS
