THE NAME OF THE CORPORATION IS **R. & C. H. TRUCKING, INC.**

**ARTICLE TWO**

THE PERIOD, TERM AND DURATION IS **PERPETUAL**.

**ARTICLE THREE**

THIS BUSINESS, IF GRANTED CORPORATE STATUS WILL COMMENCE ITS' BUSINESS AS A FULL SERVICE TRANSPORTATION CARRIER, WHEREIN, WE WILL PROVIDE TRANSPORT SERVICES FOR THE U.S. POSTAL SERVICE. THE BUSINESS WILL TRANSACT ALL OF ITS' BUSINESS UNDER THE NAME OF **R. & C. H. 
