The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following articles of incorporation.

ARTICLE ONE

The name of the corporation is VITAMIN C FOR THE CAUSE, INC.

The term of existence of the corporation is perpetual and shall commence as of the date of the signing of these Articles.
