ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, Richard Yahl, Jr., being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME
