The undersigned, natural person who are twenty-one years or older for the purpose of forming a corporation in accordance with the Double A Incorporated Law of the State of Florida, hereby certify:

Article I. Name. The name of the corporation is Double A Incorporated (Corporation).

Article II. Principal Office. The office of Corporation is located at 2175 State Road 84, Fort Lauderdale, Florida 33312
