The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

## ARTICLE I

#### Name

The name of the corporation is Big Bend Machine & Tool Co.

#### **ARTICLE II**

## Term of Existence

The corporation shall have perpetual existence, commencing upon April 15, 1998, or such other date no more than five (5) days prior to the filing of these Articles of Incorporation with the Florida Department of State, whichever is later.
