

ARTICLES OF INCORPORATION OF AIELLO MAINTENANCE, INC.

THE UNDERSIGNED, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I-NAME

The name of this corporation is Aiello Maintenance, Inc.

ARTICLE II-EFFECTIVE DATE AND DURATION
