9. SHAREHOLDERS ARE AS FOLLOWS:

- right to purchase shares (and securities convertible into shares) of any class, kind or series of stock in the corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares he holds at the time of the issue bears to the total number of shares by any shareholder who does not exercise and pay for the share pre-empted within thirty (30) days of receipt of notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares and inviting him to exercise pre-emptive rights. The right may be waived by affirmative written waiver submitted by the shareholder to the corporation.
 - 11. **FORMAL ACTION OF DIRECTORS:** If the majority of the directors consent in writing to any action taken or to be taken by the corporation and the writings evidence

therein consent filed with the secretary of the corporation, the action shall be valid as though authorized in a meeting of the board of directors.
