The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

### ARTICLE 1. - NAME AND ADDRESS

The name of this corporation is **Quality Mining of Charlotte County, Inc.**, a Florida corporation, and the principal office and place of business is located at 1777 Tamiami Trail, Suite 505, Port Charlotte, Florida, 33948.

### ARTICLE 2. - DURATION OF CORPORATION EXISTENCE

This corporation shall exist perpetually.

### **ARTICLE 3. - PURPOSES**
