

ARTICLE I CORPORATE NAME

The name of the Corporation is Southern Industrial Lubricants Inc.

ARTICLE II PURPOSE

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Law of the State of Florida other than the banking business, the trust company business, or the practice of a profession permitted to be incorporated by the State of Florida's Corporations Code.
