**NAME**

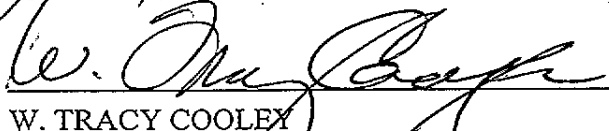
