

ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

1.01 The name of this corporation is THE PEOPLE'S TRIAL ADVOCATES INTERNATIONALE', INC.

ARTICLE TWO

2.01 The corporation is to have perpetual existence.

ARTICLE THREE

3.01 The purpose for which the corporation is organized is to do any lawful business, but more particularly, to spearhead consumer complaint litigation. The Corporation may engage in the stated business or specific profession and in any other transaction or business, permitted under the laws of the United States and of this State.

ARTICLE FOUR

4.01 The aggregate number of shares which the corporation shall have the authority to issue is 100, all of which shall be common shares with a par value of \$1.00 per share.

4.02 The minimum amount of paid-in capital with which the corporation shall begin business shall be not less than One Hundred Dollars (\$100.00).

ARTICLE FIVE

5.01 The street address of the initial corporate office of the corporation is 600 Biscayne Drive, West Palm Beach, Florida 33401.

5.02 The name and address of the initial Registered Agent for this corporation to accept service of process within the State of Florida is Barry N. Klein, 600 Biscayne Drive, West Palm Beach, Florida 33401.

ARTICLE SIX

6.01 The name and address of the incorporator of this

corporation is Barry N. Klein, 600 Biscayne Drive, West Palm Beach, Florida 33401.

6.02 Said incorporator is over the age of eighteen (18) years; is sui juris, and is a citizen of the United States.

#### ARTICLE SEVEN

7.01 Two (2) directors shall constitute the initial Board of Directors of the corporation, but the Bylaws may provide for such increase or decrease in number thereof as is authorized by law.
