SELL HIS SHARES OF STOCK, HE SHALL FILE NOTICE IN WRITING OF

SUCH INTENTION WITH THE SECRETARY OF THE CORPORATION, STATING

THE PRICE AND TERMS UPON WHICH HE DESIRES TO SELL SUCH STOCK, AND UNLESS THE TERMS OF SUCH OFFER ARE ACCEPTED BY THE CORPORATION WITHIN TEN DAYS, IT SHALL BE DEEMED TO HAVE WAIVED IT'S PRIVILEGE OF PURCHASING.
