**ARTICLE I - NAME**

The name of the corporation Continental Finance (International), Corp., located at 322 Lake Crest Court, Weston, Florida 33326.

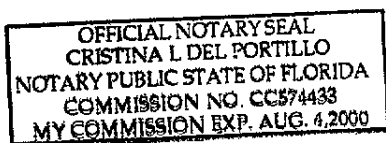
