**ARTICLE I

LIABILITY OF DIRECTORS**

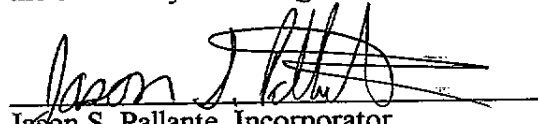

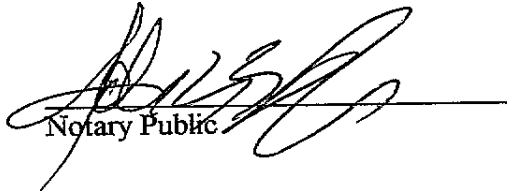

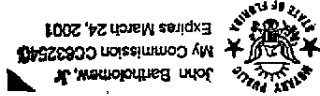
