ARTICLE I

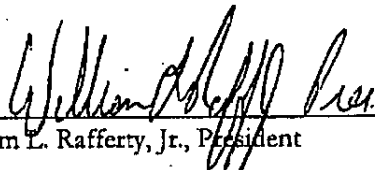
NAME
