ARTICLES OF AMENDMENT To the Articles of Incorporation of BARNET WORLDWIDE ENTERPRISES, INC.

The Articles of Incorporation of BARNET WORLDWIDE ENTERPRISES, INC. filed April 27, 1998 are hereby amended pursuant to Fla. Stat. 607.1006, as follows:

I. Article III is revised to read as follows:

Article III - Capital Stock. The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is Ten Million (10,000,000) shares of common stock having a nominal or par value of One Hundredth of a Cent (\$.0001) per share.

- 2. Existing shares issued from the previously authorized amount of 500 shares will be exchanged for new shares on the basis of 20,000 new shares for each previously issued share.
- 3. This Amendment to the Articles of Incorporation of BARNET WORLDWIDE ENTERPRISES, INC. was adopted on March 31, 1999 by written consent signed by shareholders holding a majority of the shares of the Corporation, pursuant to Fla. Stat. \$607.0704(1). The number of votes cast for this Amendment was sufficient for approval, and such vote was, in fact, unanimous in favor of this Amendment.
