The name of this corporation is Lynn Bishop & Associates, Inc. Its principal place of business is 3280 S. Shore Drive, Unit 85C, Punta Gorda, Florida 33955 and its mailing address is Post Office Drawer 511447, Punta Gorda, Florida 33951-1447.

ARTICLE II.

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.

ARTICLE III.

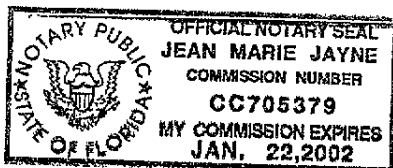
