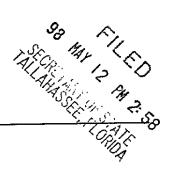

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF H. ROSS HARRIS, P.A.



Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is H. ROSS HARRIS, P.A.
