Dear Sir or Madam:

My client has asked that I respond to your 2<sup>nd</sup> request for the UBR and assures me that they sincerely were not in receipt of the 1<sup>st</sup> UBR! I noticed that the mailing address for UBR is the Officer's old residence, probable contributing factor to them not receiving the 1<sup>st</sup> UBR.

Although the Corporation has only been in business for several years, they have never been late on any Federal or State licensing or tax requirements. To assure that the UBR will be timely filed next year (or requested should it not arrive by mail), the Corporation has included the filing requirement on next year's April 2003 calendar.

Finally, the economy has slowed significantly from the prior years and has resulted in a significant decrease in their revenues. As such, the \$550 fee does create a financial hardship on the Corporation.

We are including the original filing fee of \$150 and respectfully ask that you consider the above as ~~reasonable cause to abate the late filing charge.~~
