THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I

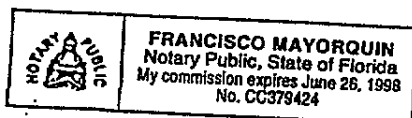
