#### ARTICLES OF INCORPORATION

### SUBURBAN ACRES INC.

### Article 1. Name of Corporation:

The name of the corporation shall be SUBURBAN ACRES, INC.

Article 2. General Nature of the Business:

The general nature of the business is to engage in any lawful activity permitted under the Constitution and Statutes of the State of Florida.

### Article 3. Stock:

The total number of shares authorized is 60 shares of common stock without par value, which stock shall be fully paid and non-assessable.
