ARTICLE I

NAME

The name of this Corporation is Blades Ice Arena, Inc.

ARTICLE II

DURATION

This Corporation shall have perpetual existence.

ARTICLE III

PURPOSE

This Corporation is organized for the purpose of conducting all lawful business.

ARTICLE IV

CAPITAL STOCK

The Corporation is authorized to issue 2,000 shares (1,000 voting and 1,000 non-voting) of \$1.00 par value common stock, which shall be designated "common shares".

ARTICLE V

PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as

nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

The directors or shareholders of this Corporation may take action by written consent as provided by law.

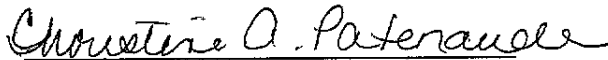
