## ARTICLE VIII PRE-EMPTIVE RIGHTS

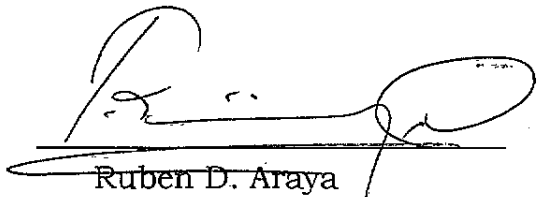

manifesting their intention that a certain amendment of these Articles of Incorporation be made.

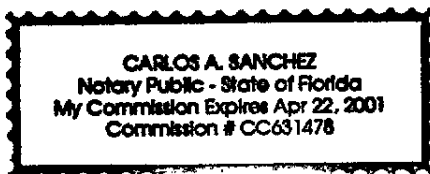

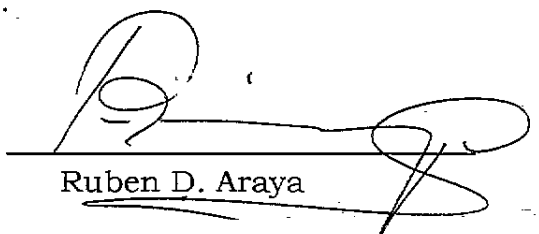
