ARTICLES OF INCORPORATION

OF

NATALEX CORP.

Article 1. Name of Corporation:

The name of the corporation shall be NATALEX CORP.

Article 2. General Nature of the Business:

The general nature of the business is to engage in any lawful activity permitted under the Constitution and Statutes of the State of Florida.
