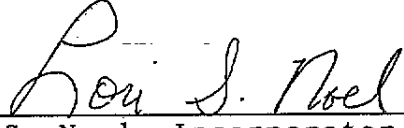
ARTICLE ONE: NAME - The name of the proposed corporation is: PeopleTech Solutions, Inc.
