ARTICLES OF INCORPORATION  
OF  
**ACCURATE SECRETARIAL SERVICES, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I.  
Name and Address

The name of the corporation is **ACCURATE SECRETARIAL SERVICES, INC.** The principal office is 3515 N. Brookshire Point, Crystal River, FL 34428, and the mailing address for the corporation is 3515 N. Brookshire Point, Crystal River, FL 34428.

ARTICLE II.  
Duration

The duration of the corporation is perpetual.

ARTICLE III.  
Purpose

The general purposes for which the corporation is organized are the following:

A. To provide accurate secretarial services to the general public and commercial establishments.

B. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

C. To do such other things as are incidental to the purpose of the corporation or necessary or desirable in order to accomplish them.


ARTICLE VII.

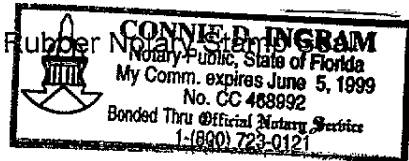
