ARTICLE I - NAME

The name of this Corporation is HEALTH CARE OFFICE, INC.

This Corporation shall have perpetual existence commencing  
on April 23, 1998.

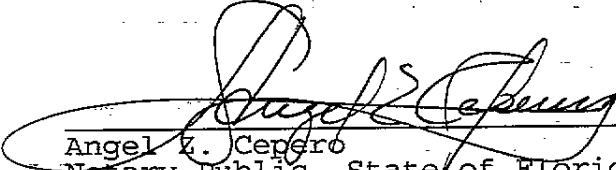

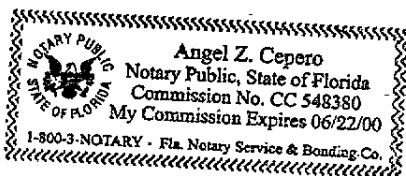
