NAME

The name of this corporation is Lewis, Lerner & Associates, Inc.

ARTICLE II

DURATION

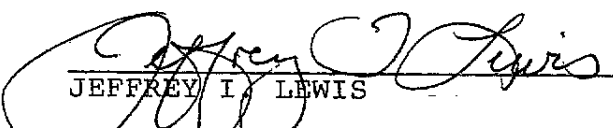

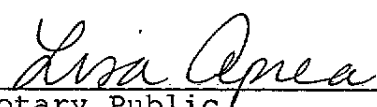

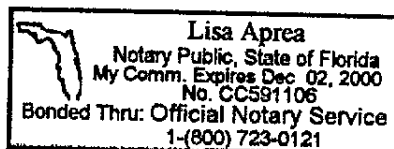
