ARTICLES OF INCORPORATION
OF

SAFETOUCH OF ORLANDO, INC.

ARTICLE I - NAME

The name of this Corporation is SAFETOUCH OF ORLANDO, INC., and the principal business address of the Corporation is 9600 Sunbeam Center Drive, Jacksonville, Florida 32257.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the date of execution of these Articles of Incorporation. This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL

This Corporation is authorized to issue:

1. 1,000 shares of voting common stock, all of which shall have a par value of \$1.00 per share (the "Voting Common Shares") and
2. 1,000 shares of non-voting common stock all of which shall have a par value of \$1.00 per share (the "Non-Voting Common Shares"). The Non-Voting Common Shares shall be without voting rights and shall not be entitled to vote.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 701 Brickell Avenue, Suite 3000, Miami, Florida, 33131, and the name of its initial registered agent at such address is Intrastate Registered Agent Corporation.


