# ARTICLES OF INCORPORATION OF FLORIDA CREDIT SERVICES, INC.



# **PREAMBLE**

We, the undersigned, do hereby associate ourselves under the following Articles, for the purpose of forming a corporation under the laws of the State of Florida.

# ARTICLE I

# **NAME**

The name of the Corporation shall be:

FLORIDA CREDIT SERVICES, INC.

#### ARTICLE II

# PRINCIPAL OFFICE

The principal office of the Corporation shall be:

# ARTICLE III

# GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is:

(1) Collection of past-due debts.

(2) Engaging in any activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE IV

### CORPORATE POWERS

This Corporation shall have all powers now and hereafter granted corporations for profit under the laws of the State of Florida, including the Emergency Powers included in §607.0303, Florida Statutes.

#### ARTICLE V

#### CAPITAL STOCK

- (1) This corporation shall be authorized to have outstanding at any time a maximum of 500 shares of stock of the par value of \$5.00.
- (2) Shares of stock may be issued in consideration of the payment of the entire purchase price or only part of the purchase price, as may be determined by the Board of Directors which payment may be made in cash, property, or in services.   - (c) Certificates issued therefor shall bear endorsement as to the actual amount paid thereon.
- (3) No stock in this corporation shall be sold or transferred other than by operation of law, unless and until the record owner thereof shall have given written notice, by certified mail, to the corporation at its principal office, setting forth a desire to sell such stock, together with the price, terms and conditions upon which said stock shall be offered for sale. The corporation, if it elects, or its stockholders, if it shall not elect, shall have an exclusive right to purchase said stock at the price and upon the terms and conditions set forth in said notice at any time within thirty (30) days of the corporation's receipt thereof. Upon failure of the

corporation or its stockholders to exercise such rights within such thirty (30) day period, said stock may be offered for sale to others, but only at the price and upon the terms and conditions stated in said notice.

(4) Anything to the contrary notwithstanding, the original subscribers hereto shall, prior to issue of certificates therefor, have the right to assign their stock subscriptions without regard to the limitations on stock transfers contained in Section (3) above.
