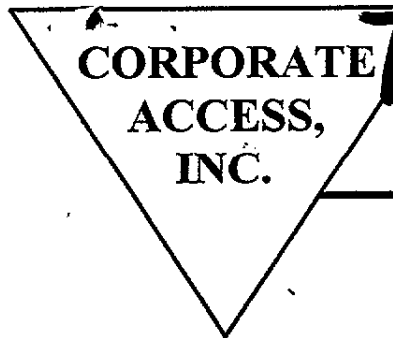

**ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as sole incorporator of MOBILE DIAGNOSTICS, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is Mobile Diagnostic Center, Inc.

**ARTICLE II
SHARES**

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, One Cent (\$0.01) par value per share.

**ARTICLE III
PRINCIPAL OFFICE**

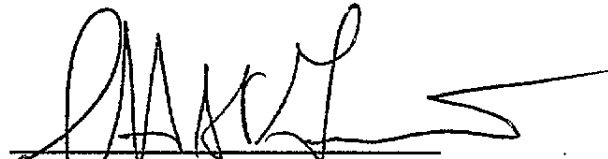
ARTICLE VII
