

# ARTICLES OF INCORPORATION OF DHAKA FOOD CORPORATION



The undersigned incorporator to these Articles of Incorporation, a natural person, competent to contract, hereby forms a Corporation under the laws of the State of Florida.

## **ARTICLE I - NAME**

The name of the Corporation shall be **DHAKA FOOD CORPORATION**.

#### <u>ARTICLE II - PRINCIPAL OFFICE</u>


