All remaining assets have been distributed to the Shareholders according to their respective rights and interests.

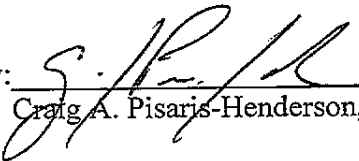
ARTICLE FIVE
