Pursuant to the provisions of Section 607.0501 or 617.0501 of the Florida Statutes, this corporation adopts the following Articles of Incorporation:

Article 1. - Name and Principal Office

The name of the corporation shall be BLOYED ENTERPRISES, INC., and the principal office address shall be 4510 OAK FAIR BLVD. SUITE 202, TAMPA Florida 33655. The type of corporation: Close.

Article II. - Purpose

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

Article III. - CAPITAL STOCK

The amount of capital stock authorized shall consist of 100 shares of common voting stock having no par value per share. The capital stock of the corporation may at any time be increased or decreased as provided by the laws of Florida.

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE XI.- AMENDMENT
