ARTICLES OF INCORPORATION
OF
CUSTOM PRINTING & PROMOTIONS, INC.

The undersigned natural person, acting hereby as Incorporator for the purposes of forming a corporation for profit under the provisions of the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is **Custom Printing & Promotions, Inc.**

ARTICLE II

The principal office of the corporation shall be located at:

Tallahassee, Florida 32317**

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

The general purposes for which the corporation is organized are:

1. To engage in the business of all aspects of commercial printing and event promotions.
2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
3. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE V

The aggregate number of shares which the Corporation is authorized to issue is 100 . Such shares shall be of a single class of common stock only, and shall have a par value of \$.01 per share.

ARTICLE VI

The principal place of business for the Corporation shall be located at Post Office Box 13871, Tallahassee, Florida, but the Corporation may establish and maintain its principal office at such other place within the State of Florida as may be determined by the Board of Directors.

The name and address of the registered agent is Wendy Russell Wiener, Esq., 660 East Jefferson Street, Tallahassee, Leon County, FL 32301.

ARTICLE VIII

The number of Directors constituting the initial Board of Directors is one (1). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one (1). The name and address of the person who is to serve as the initial Director is:

ARTICLE IX

The power to adopt, alter, amend, or repeal by-laws shall be vested in the Board of Directors.

ARTICLE X

The Corporation reserves the right to amend, alter, or repeal any provision in these Articles of Incorporation, and all rights conferred on shareholders are subject to this reservation. These articles may be amended prior to the issuance of shares of the Corporation by the approval or consent of the shareholders.
