ARTICLES OF INCORPORATION

OF

DONALD KLOTTER, INC.

The undersigned Incorporator, being a person competent to contract, subscribes to these Articles of Incorporation to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is Donald Klotter, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal office of the corporation is 2417 North Ramona Circle, Tampa, FL 33612. The mailing address of the corporation is 2417 North Ramona Circle, Tampa, FL 33612.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that the corporation is authorized to issue is 10 shares of common stock having no par value per share. The consideration to be paid for each share shall be fixed by the Board of Directors.

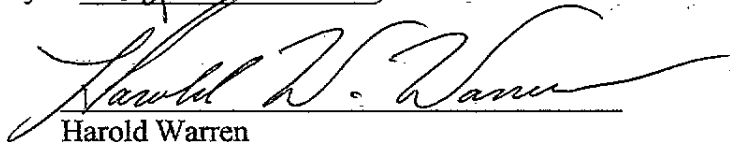
ACCEPTANCE OF APPOINTMENT
